 same disclosure events mentioned above.

In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?

Allegations: Without admitting or denying the findings, Muharemovic consented to the

sanctions and to the entry of findings that he engaged in excessive and unsuitable trading, including using margin, in customer accounts. The findings stated that Muharemovic recommended that his customers place trades in their accounts - nearly all of which were executed using margin - and the customers routinely accepted his recommendations. Muharemovic's recommendations resulted in annualized turnover rates ranging from 5.71 to 19.26 and annualized cost-to-equity ratios ranging from 30.12 percent to 74.25 percent. As a result of Muharemovic's unsuitable recommendations, his customers lost approximately \$237,823, and paid approximately \$211,643 in commissions, fees, and margin interest.
