IAPD Information About Representatives

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: Without admitting or denying the findings, Mangini consented to the sanctions and to the entry of findings that he participated in unapproved private securities transactions. The findings stated that Mangini, in his capacity as an investment advisor representative, recommended and facilitated investments in private securities offerings of alternative investments through a registered investment advisory firm. Mangini participated in securities transactions through the registered investment advisory firm that raised \$644,000 from investors, all of whom were customers at his member firm. Mangini participated in the transactions by recommending and facilitating the investments, including by meeting with the investors to solicit and discuss the investments, providing them with marketing materials, and assisting them with completing subscription agreements and other documentation. Mangini's clients paid advisory fees to the registered investment advisory firm on the assets held in their advisory accounts, including the alternative investments that he recommended and facilitated. Mangini did not provide his firm with prior written notice of his participation in the sale of alternative investments through the registered investment advisory firm or obtain the firm's written approval to sell those investments.
